## PRE-CONSTRUCTION MEETING AND GENERAL INFORMATION

Prior to beginning work, the Contractor may be required to contact the Public Works Department and request a pre-construction meeting with a representative of the City. The requirements of the City will be discussed and clarified, and any proposed variation from these requirements will be considered at this meeting. If the work involves road closure(s), lane closures or other traffic restrictions, a Traffic Control Plan may be required. Contractors are to call (530) 538-2507 to discuss the level of traffic control required for the proposed work. All work authorized by this encroachment permit shall be completed in accordance with City of Oroville Construction Standards, and any City standard drawings attached to the encroachment permit at the time of issuance. Contractors that initiate work in any City Right-of-Way without first securing an Encroachment Permit and paying the required fee risk having their City Business License suspended, and may be reported to the State Contractors License Board.

## **INSPECTION SCHEDULE**

Improvements installed in the City of Oroville shall be inspected and approved by authorized representatives of the City of Oroville, Department of Public Works, as indicated in the table below. The Contractor shall contact the Public Works Department and request inspections 48-hours in advance to allow City personnel the opportunity to schedule the inspection. In the event that a City Inspector is not on the job site at the time scheduled for the inspection, the Contractor shall contact the City and arrangements will be made for an Inspector to be at the job site as soon as possible. In no case shall the Contractor proceed to the next stage of the work prior to inspection and approval by a Public Works Department Inspector.
